Contains a natural mixture of triglycerides, phospholipids, and glycolipids, with a small amount of carbohydrates.

**Regulatory Status:** Certified organic under the USDA National Organic Program (NOP) by QAI (Quality Assurance International); certified Kosher and Pareve by KSA (Kosher Supervision of America); Certified Halal by IFANCA (Islamic Food and Nutrition Council of America). Produced without the use of genetic engineering, irradiation, sewage sludge or the use of solvents including hexane. Generally recognized as safe (GRAS) as a multi-purpose food additive under Title 21 CFR 184.1400. Not listed under California Prop 65. Made from soybeans certified organic under USDA NOP which requires farmers to use non-GMO seed to be certified organic.

**Storage Conditions:** This product should be stored at temperatures between 40° F and 100° F. Avoid excessive exposure to light and moisture. The shelf life is a minimum of 36 months when stored unopened in the original container.
